

EXECUTIVE DIRECTOR SEARCH COMMITTEE MINUTES Tuesday, December 9, 2014

The meeting of the five member Mississippi Community College Board (MCCB) Executive Search Committee was held at 1:30 p.m. on Tuesday, December 9, 2014, at the offices of the Mississippi Community College Board, 3825 Ridgewood Road, Room 507, of the Education and Research Center in Jackson, Mississippi. Members present: Mr. Bruce Martin, Chairman; Mr. Bubba Hudspeth; Mr. Lee Bush; Mrs. Cheryl Thurmond. Mr. Tom Gresham participated in discussions via conference call, but did not vote.

CALL TO ORDER

Chairman Martin called the meeting to order at 1:30 p.m.

Approval of Agenda

In a motion made by Mr. Bubba Hudspeth and seconded by Mr. Lee Bush, the Executive Director Search Committee **voted unanimously** to approve the Executive Director Search Committee's December 9 agenda.

EXECUTIVE SESSION

Mrs. Cheryl Thurmond moved that the meeting be closed to go into executive session to discuss individual applicants as potential candidates for the MCCB Executive Director position. Mr. Lee Bush seconded the motion. The meeting was closed to consider the motion. Following discussion of the need for an executive session, the motion **passed unanimously**. The meeting was reopened and a public announcement was made that the committee voted to go into executive session to discuss individual applicants as potential candidates for the position of MCCB Executive Director. The meeting was then closed to the public for that purpose.

Following discussion of the applicants and their qualifications, Mr. Lee Bush moved that the meeting be reopened to the public. Mrs. Cheryl Thurmond seconded the motion. The motion **passed unanimously**. The meeting was reopened to the public.

Chairman Martin instructed MCCB staff to hire an independent firm to conduct reference and background checks on the two remaining candidates for the MCCB Executive Director position.

OTHER BUSINESS



ADJOURNMENT


