SENATE CONCURRENT RESOLUTION NO. 619

A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING THE 2013 LAKE CORMORANT HIGH SCHOOL "LADY GATORS" GIRLS VOLLEYBALL TEAM AND COACH CHRISTINA MORGAN FOR THEIR SECOND CONSECUTIVE MHSAA CLASS II STATE CHAMPIONSHIP.

WHEREAS, the 2013 Lake Cormorant High School "Lady Gators" Girls Volleyball Team won its second consecutive Mississippi High School Activities Association Class II State Championship with November's 2013 25-19, 25-12, 25-20 victories over East Central at Mississippi College in Clinton; and

WHEREAS, the Lady Gators, coached by Christina Morgan, wrapped up their season with a 26-11 record; and

WHEREAS, the Class II State Championship was the third for Lake Cormorant and for Coach Christina Morgan. The Lady Gators' three title successes have all come since 2009: Champs in 2009/2012/2013; and

WHEREAS, DeSoto County schools have been the benchmark for volleyball in Mississippi high schools, since Horn Lake won the first State Championship in 1995. Fifteen State Championships

have been won by DeSoto County Volleyball Squads. In 2013, DeSoto County schools again brought State Championship Trophies home from Mississippi College as Southaven and Lake Cormorant both succeeded in their quests for the state's "Gold Balls"; and

WHEREAS, these are exciting times for DeSoto County Girls Volleyball; and it is with great pride that we recognize these student athletes who have brought honor to their school, their community and to the State of Mississippi:
