- 1 Tech center is right behind McDonald's across from Hardy Court Shopping Center
- 2 JMG is 6055 Ridgewood Rd., Suite A (near County Line)
- 3 Clifton is at Tupelo Middle School; Angie Cherry said she would meet me there.
- 5 As entering Corinth from Tupelo, exit right @ sign for Vocational Center, then left. Will come to 4-way stop (new Crossroads Arena on right). Keep going west at 4-way stop on Harper Road, which will deadend at Norman Rd. Turn right and will see Vocational Center on right (not 1/4 mile from 4-way stop).
- 6 From Corinth, take Hwy 45 to Hwy 30 West; go approx 25 miles; take left at Highway 15 light (head south); school will be approx 1/4 mile and on right; will see band field out front; vo tech center is first bldg on right
