We received the attached resolutions in the mail today from Dr. Arthur Kaul, President of the University Faculty Senates Association of Mississippi. The Association passed these 2 resolutions at its last meeting.

The first resolution requests the state leadership to ensure consistent, equitable and fair annual salary increases for IHL faculty, beginning with a 4% salary increase for the 2002-2003 school year. (NOTE: IHL and all 8 universities requested the same during their budget hearings.)

The second resolution requests the Legislature to revise the makeup of the College Board.

Dr. Kaul's memo also requests a meeting with you and the Association's representatives to discuss these and other concerns of faculty members. They are requesting the same of the Lt. Governor.
