TO THE MISSISSIPPI STATE SENATE:

I am directed by the Governor to advise you that he has approved the following Senate Bills:

NO. 2032: AN ACT TO AMEND SECTION 43-1-28, MISSISSIPPI CODE OF 1972, TO CLARIFY THE DATES REQUIRING THE DEPARTMENT OF HUMAN SERVICES TO DEVELOP AND IMPLEMENT THE ON-LINE ELECTRONIC BENEFIT TRANSFER (EBT) SYSTEM FOR FOOD STAMPS AND TO REVISE THE CRITERIA FOR AN EBT SYSTEM PILOT PROJECT; AND FOR RELATED PURPOSES. NO. 2290: AN ACT TO AMEND SECTION 33-15-307, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE USE OF THE DISASTER ASSISTANCE TRUST FUND FOR PUBLIC ASSISTANCE UNDER A STATE OF EMERGENCY DECLARED BY THE GOVERNOR; TO AMEND SECTION 33-15-313, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT A STATE OR LOCAL AGENCY SHALL MAKE APPLICATION FOR STATE AND/OR FEDERAL FINANCIAL ASSISTANCE WITHIN 60 DAYS AFTER THE DATE OF THE DECLARATION OF A STATE OF EMERGENCY BY THE GOVERNOR; TO AMEND SECTION 33-15-317, MISSISSIPPI CODE OF 1972, TO REVISE THE MAXIMUM LIMIT ON THE ADVANCE OF FUNDS WHICH A STATE OR LOCAL AGENCY MAY RECEIVE TO INITIATE A PROJECT UNDER A STATE OF EMERGENCY DECLARED BY THE GOVERNOR; TO AMEND SECTION 43-41-13, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT IN THE EVENT OF A GOVERNOR'S STATE OF EMERGENCY DECLARATION, THE STATE GRANTS AWARDED TO INDIVIDUALS AND FAMILIES UNDER THE STATE'S NATURAL DISASTER PLAN SHALL BE EQUAL TO AN AMOUNT ESTABLISHED BY THE DIRECTOR OF THE MISSISSIPPI EMERGENCY MANAGEMENT AGENCY; AND FOR RELATED PURPOSES. S.B. NO. 2333: AN ACT TO AMEND SECTION 41-7-191, MISSISSIPPI CODE OF 1972, TO EXTEND THE AUTOMATIC REPEALER ON THE EXEMPTION FROM THE HEALTH CARE CERTIFICATE OF NEED REQUIREMENT FOR CONTINUING CARE RETIREMENT HOME FACILITIES MEETING CERTAIN CRITERIA; AND FOR RELATED PURPOSES. (March 11, 2001; 3:02 PM)

S.B. NO. 2334: AN ACT TO AMEND SECTION 45-35-3, MISSISSIPPI CODE OF 1972, TO REVISE AGE OF ELIGIBILITY FOR ISSUANCE OF A NONDRIVER'S IDENTIFICATION CARD; AND FOR RELATED PURPOSES. (March 11, 2001; 3:03 PM)

S.B. S.B. NO. 2821: AN ACT TO AMEND SECTION 69-11-5, MISSISSIPPI CODE OF 1972, TO ALLOW THE DEPARTMENT OF CORRECTIONS TO FEED COOKED GARBAGE AND VEGETABLE REFUSE TO SWINE; TO AUTHORIZE THE DEPARTMENT OF CORRECTIONS TO USE OR MARKET SUCH SWINE; AND FOR RELATED PURPOSES. (March 11, 2001; 3:18 PM)
