TO THE MISSISSIPPI STATE SENATE:

I am directed by the Governor to advise you that he has approved the following Senate Bills:

S.B. NO. 3082: AN ACT TO AUTHORIZE THE BOARD OF SUPERVISORS OF MARSHALL COUNTY, MISSISSIPPI, TO EXPEND COUNTY FUNDS AS MATCHING FUNDS NECESSARY FOR THE CONTINUATION OF THE COMMUNITY SOCIAL SERVICE PROGRAMS SPONSORED BY THE INSTITUTE OF COMMUNITY SERVICES, INCORPORATED; AND FOR RELATED PURPOSES. (April 7, 2001; 6:42 AM)

S.B.
