TO THE MISSISSIPPI HOUSE OF REPRESENTATIVES:

I am directed by the Governor to advise you that he has approved the following House Bill:

H.B. NO. 463: AN ACT TO REENACT SECTIONS 81-12-1 THROUGH 81-12-207, MISSISSIPPI CODE OF 1972, WHICH PROVIDE FOR THE REGULATION OF SAVINGS ASSOCIATIONS; TO AMEND REENACTED SECTION 81-12-143, MISSISSIPPI CODE OF 1972, TO INCREASE THE MAXIMUM AMOUNT THAT SAVINGS AND LOAN ASSOCIATIONS MAY PAY TO THE SUCCESSORS OF DECEASED DEPOSITORS WITHOUT NECESSITY OF ADMINISTRATION; TO REPEAL SECTION 81-12-209, MISSISSIPPI CODE OF 1972, WHICH IS A REPEALER ON THE STATUTES PROVIDING FOR THE REGULATION OF SAVINGS ASSOCIATIONS; AND FOR RELATED PURPOSES. H.B. NO. 471: AN ACT TO AMEND SECTION 41-89-1, MISSISSIPPI CODE OF 1972, WHICH CREATES THE INFANT MORTALITY TASK FORCE, TO EXTEND THE REPEAL DATE FROM JULY 1, 2001, TO JULY 1, 2005; AND FOR RELATED PURPOSES. (March 24, 2001; 6:32 AM)

H.B. NO. 540: AN ACT TO AMEND SECTION 5-3-93, MISSISSIPPI CODE OF 1972, TO REQUIRE THE STANDING JOINT LEGISLATIVE COMMITTEE ON REAPPORTIONMENT TO PREPARE A PLAN FOR APPORTIONING THE HOUSE AND SENATE NO LATER THAN FIFTEEN DAYS PRIOR TO THE SCHEDULED ADJOURNMENT OF THE REGULAR SESSION FOLLOWING THE DELIVERY OF THE DECENNIAL CENSUS DATA TO THE STATE; TO AMEND SECTIONS 5-3-95 AND 5-3-125, MISSISSIPPI CODE OF 1972, TO REMOVE THE PROVISION THAT PROHIBITS MEMBERS OF THE STANDING JOINT LEGISLATIVE COMMITTEE ON REAPPORTIONMENT AND THE STANDING JOINT CONGRESSIONAL REDISTRICTING COMMITTEE FROM BEING PAID PER DIEM COMPENSATION AND REIMBURSEMENT FOR EXPENSES FOR MORE THAN 30 CALENDAR DAYS AND TO REVISE THE COMPENSATION FOR ATTENDING MEETINGS OF SUCH COMMITTEES; AND FOR RELATED PURPOSES. H.B. NO. 819: AN ACT TO AMEND SECTION 19-5-353, MISSISSIPPI CODE OF 1972, TO PROHIBIT PRIVATE "FOR PROFIT" AMBULANCE, SECURITY OR FIRE SERVICE COMPANIES FROM PAYING A SALARY TO PUBLIC SAFETY AND 911 TELECOMMUNICATORS WHO HAVE NOT MET MINIMUM TRAINING STANDARDS; TO AMEND SECTION 19-5-357, MISSISSIPPI CODE OF 1972, TO AUTHORIZE SUCH COMPANIES THAT ARE UNDER CONTRACT WITH A LOCAL GOVERNMENT TO BE REIMBURSED MINIMUM STANDARDS TRAINING FUNDS; AND FOR RELATED PURPOSES.
