**PUBLIC NOTICE NUMBER L9-3430
Non-Resident Hunting and Fishing License & Fee Program**

The Mississippi Commission on Wildlife, Fisheries, and Parks, at a meeting in Jackson, MS on May 18, 2005, made known its intent and thirty days thereafter did adopt the following rules and regulations pertaining to Non-Resident Hunting and Fishing Licenses and Fees. This action is being taken under authority of Sections 49-1-29, 49-7-3 and 49-7-8 in accordance with Section 25-43-3.103, Mississippi Code of 1972.

Be it ordered that Public Notice No. L8-3430 is hereby amended as follows:

NON-RESIDENT HUNTING AND FISHING LICENSE & FEE PROGRAM

I. Non-Resident required to Possess License

- A. Effective July 1, 1994, license will be required of all non-residents fishing in the fresh or marine waters or hunting in the State of Mississippi, except minors who have not reached the age of sixteen (16) years.
- B. Non-Resident Defined.

Any person not entitled to receive a resident fishing license under the provisions of Section 49-7-3, Mississippi Code of 1972, shall be considered a non-resident for purposes of obtaining a fishing license.

Any person not entitled to receive a resident hunting license under the provisions of Section 49-7-3, Mississippi Code of 1972, shall be considered a non-resident for purposes of obtaining a hunting license.

No non-resident twelve (12) to fifteen (15) years of age, nor any non-resident born on or after January 1, 1972, may hunt, kill, take, chase or trap any wild animal or bird without having acquired and having in his/her possession, proof of satisfactory completion of an approved hunter education course.

II. Agent's Issuance Fee

- A. The agent's issuing fee for non-resident license shall be:

- \$3.00 fee for each license (except the 3-day fishing license);
- \$2.00 fee for each 3-day fishing license;
- \$1.00 fee for each 1-day freshwater fishing license;
- \$1.00 fee for each state waterfowl stamp;
- \$1.00 fee for each fall turkey permit; and
- No Fee for trapping, fur dealer, and shooting preserve license

III. Expiration Date:

- A. All license shall be good from the date of issuance through June 30 following such issuance with the exception of 3 and 7-day license and the non-resident fur dealer's license. The non-resident fur dealer's license will expire one year from date of issuance.

IV. Replacement Policy:

- A. License and waterfowl stamps, with the exception of all 3 and 7-day license, will be replaced at a charge of \$5.00 each when lost or destroyed. The licensee must submit an application for duplicate license as supplied by the Department, along with a cashier's check or money order in the amount of \$5.00 for each duplicate license and/or stamp.

V. Policy on Shooting Preserves:

- A. Non-residents hunting on shooting preserves shall be required to possess either a regular non-resident hunting license or special non-resident shooting preserve license as prescribed in this public notice. The shooting preserve license is good for the entire shooting preserve season on any such property in the state, for the taking of legal shooting preserve game only.
- B. In accordance with Section 49-11-21, Mississippi Code of 1972, non-residents hunting wild game found on shooting preserves shall be required to possess a regular non-resident hunting license in addition to the shooting preserve license prescribed in this public notice.

VI. License Types and prices for **Non-Residents**:

1. Fishing:

Annual Fishing	(Freshwater)	\$50.00
Required for fishing in the freshwaters of Mississippi.		
3-Day Fishing	(Freshwater)	\$15.00
Required for fishing in the freshwaters of Mississippi for three (3) consecutive calendar days (not a 72-hour period).		
1-Day Fishing	(Freshwater)	\$8.00
Required for fishing in the freshwaters of Mississippi for one (1) calendar day.		

2. Hunting:

All Game Hunting	\$300.00
Required for hunting all game and fowl in Mississippi as provided by law. Hunters hunting during special archery or primitive weapon seasons will be	

required to purchase an archery/primitive weapon permit in addition to this license. Hunters hunting waterfowl will be required to purchase both a state and a federal waterfowl stamp in addition to this license. Hunters hunting turkey during fall either-sex seasons will be required to purchase a fall turkey permit in addition to this license.

All Game Hunting (Ages 16, 17, and 18) \$110.00

Required for hunting all game and fowl in Mississippi as provided by law. Hunters hunting during special archery or primitive weapon seasons will be required to purchase an archery/primitive weapon permit in addition to this license. Hunters hunting waterfowl will be required to purchase both a state and a federal waterfowl stamp in addition to this license. Hunters hunting turkey during fall either-sex seasons will be required to purchase a fall turkey permit in addition to this license. Available to any non-resident who has not yet reached the age of 19 years.

3-Day All Game Hunting - Archery / Primitive Weapon \$125.00

Required for hunting all game and fowl in Mississippi as provided by law. This license includes all game and archery/primitive weapon hunting. Hunter hunting waterfowl will be required to purchase both a state and a federal waterfowl stamp in addition to this license. Hunters hunting turkey during fall either-sex seasons will be required to purchase a fall turkey permit in addition to this license. This license is valid for three (3) consecutive calendar days (not a 72-hour time period).

7-Day All Game Hunting \$125.00

Required for hunting all game and fowl in Mississippi as provided by law. Hunters hunting during special archery or primitive weapon seasons will be required to purchase an archery/primitive weapon permit in addition to this license. Hunters hunting waterfowl will be required to purchase both a state and a federal waterfowl stamp in addition to this license. Hunters hunting turkey during fall either-sex seasons will be required to purchase a fall turkey permit in addition to this license. This license is valid for seven (7) consecutive calendar days (not a 168 hour time period).

7-Day All Game Hunting (Ages 16, 17, and 18) \$60.00

Required for hunting all game and fowl in Mississippi as provided by law. Hunters hunting during special archery or primitive weapon seasons will be required to purchase an archery/primitive weapon permit in addition to this license. Hunters hunting waterfowl will be required to purchase both a state and a federal waterfowl stamp in addition to this license. Hunters hunting turkey during fall either-sex seasons will be required to purchase a fall turkey permit in addition to this license. This license is valid for seven (7) consecutive calendar days (not a 168-hour time period). Available to any non-resident who has not yet reached the age of 19 years.

Archery / Primitive Weapon **\$75.00**
Required for hunting deer during special archery/primitive weapon seasons. This license must be purchased in addition to an all-game hunting or 7-day all-game hunting license.

Crossbow **\$20.00**
Required for hunting deer with a crossbow during primitive weapon and gun deer seasons. This license must be purchased in addition to an all-game hunting or 7-day all-game hunting license.

Deer **\$5.00**
Required for hunting deer during all deer seasons. This license must be purchased in addition to an any all game, 7-day all game, or 3-day all game hunting license.

Spring Turkey **\$20.00**
Required for hunting turkey during spring turkey season. This license must be purchased in addition to an any all game, 7-day all game, or 3-day all game hunting license.

Fall Turkey **\$20.00**
Required for hunting turkey during fall either-sex seasons. This license must be purchased in addition to an any all game, 7-day all game, or 3-day all game hunting license.

Small Game Hunting **\$75.00**
Required for hunting all game and fowl, excluding deer and turkey, in Mississippi as provided by law. Hunters hunting waterfowl will be required to purchase both a state and a federal waterfowl stamp in addition to this license.

7-Day Small Game Hunting **\$30.00**
Required for hunting all game and fowl, excluding deer and turkey, in Mississippi as provided by law. Hunters hunting waterfowl will be required to purchase both a state and a federal waterfowl stamp in addition to this license. This license is valid for 5 consecutive calendar days (not a 168-hour period).

Special 7-Day Combination Hunting/Fishing **\$32.00**
Special license valid only for nonresidents who are in the state on official business or attending an official convention sanctioned by the Department, wherein the state would benefit from the issuance of the license. Valid for hunting all game and fowl, including deer and turkey, for fishing in any county in the state, and for hunting using primitive weapons and bow and arrow, as provided by law. Hunters hunting waterfowl will be required to purchase both a state and a federal waterfowl stamp in addition to this license. This license is valid for 7 consecutive calendar days (not a 168 hour time period).

This special license is issued only by the Executive Director or his designee. The Executive Director shall keep a permanent record of each license issued including the name and address of the person receiving the license and the reason the license was issued.

3. **Miscellaneous:**

Commercial Fishing (Freshwater) \$200.00/license \$3.00/per tag
Required for fishing for commercial purposes and selling or peddling fish at retail or selling or shipping same at wholesale, as to markets, dealers, or canning plants within the State of Mississippi. Each piece of equipment must be tagged. This license is also required of any non-resident who brings fish into the state from the outside of the state for the purpose of resale to a wholesale or retail dealer or to the consumer. This license is also required of any non-resident engaged in the business of selling minnows for resale for bait purpose.

Trapper \$205.00
Required of all non-resident trappers or their assistants/helpers who are sixteen (16) years or older for trapping in the State of Mississippi. Non-resident trappers are subject to the statutes and regulations applicable to Mississippi resident trappers.

Fur Dealer \$205.00
Required of all non-residents regardless of age, who buy furbearing animals from trappers and hunters. Such license shall be valid one (1) year from date of issuance, unless suspended or revoked. Non-resident fur dealers are subject to the statutes and regulations applicable to Mississippi resident fur dealers.


Shooting Preserve \$13.00
Required for hunting on shooting preserves in lieu of regular non-resident hunting license. Shooting preserve license is valid for entire shooting preserve season, for the taking of legal shooting preserve game only. **NOTE:** In accordance with Section 49-11-21, Mississippi Code of 1972, non-residents hunting wild game found on shooting preserves shall be required to possess a regular non-resident hunting license in addition to the shooting preserve license prescribed in this public notice.

This adopted public notice will become effective July 31, 2005. Witness my hand and seal this the 30th day of June 2005.




